

Rules for the "Binomismo TikTok" promotion

1. General provisions on the procedure for holding the promotion

- 1.1. The "**Binomismo TikTok**" promotion (hereinafter referred to in these Rules as the "Promotion") is held on the social network Instagram, with the aim of promoting the Binomo platform.
- 1.2. Participants of the Promotion (hereinafter referred to as the "Participants") must be legally eligible individuals.
- 1.3. By participating in the Promotion, the Participants fully agree to these Rules.
- 1.4. Participation in the Promotion is free.

2. Information about the organizer of the Promotion

- 2.1. The Promotion is organized by Dolphin Corp LLC (a company registered in accordance with the laws of Saint Vincent and the Grenadines, registration number 915 LLC 2021, whose office is located at First Floor, First St. Vincent Bank Ltd Building, James Street, Kingstown, St. Vincent and the Grenadines).
- 2.2. The website where information about the Promotion can be found is <https://binomo.com/binomism/br/> (hereinafter referred to in these Rules as the "Organizer's Site").

3. Terms and conditions of the Promotion

- 3.1. The Promotion shall be held from 22.08.2022 to 30.09.2022.
- 3.2. Each Participant is entitled to participate in the Promotion an unlimited number of times and upload an unlimited number of videos.

4. Terms and conditions of participation in the Promotion

- 4.1. In order to participate in the Promotion, you must create a video using the Binomo brand sound during the Promotion Period <https://vt.tiktok.com/ZSRDJpLs4/> describing how exactly Binomism, i.e. a superpower for predicting events in the nearest future, manifests itself in them, and post that video on your TikTok page, mentioning the hashtag #binomismo when posting.
- 4.2. The Participant creator grants the Organizer the right to use the video created by that Participant as part of their participation in the Promotion on binomo.com, via the Organizer's channels, in Binomo platform groups on social networks and other web resources, as well as in promotional materials with a link to the Participant creator's account on Instagram without any payment of royalties in the following ways: disclosure, reproduction and distribution, public performance, broadcasting, communication by cable, retransmission, communication to the public, translation into other languages, subtitling, and dubbing of the text.

4.3. The Organizer does not reimburse Participants' expenses for creating videos within the framework of their Participation in the Promotion.

5. The size of the prize fund for the Promotion

5.1. The total prize fund of the Promotion is 3 (Three) Apple Watch Series 3s (hereinafter the "Valuable Prize").

5.2. The Prizes shall be distributed among the Winners in equal share.

5.3. The Valuable Prizes cannot be substituted with the cash equivalent.

5.4. The appearance, color, and model of the Valuable Prize may differ from those shown in promotional materials.

6. The procedure for determining the Winners of the Promotion

6.1. The Winners will be chosen at random from among the Participants who have fulfilled the conditions of the Promotion by means of a randomizer on 05.10.2022.

6.2. The total number of Winners in the Promotion is 3 people.

6.3. The results of the Promotion will be posted by the Organizer on the Bastoslake on TikTok page (https://www.tiktok.com/@bastoslake?_t=8UWr8IQQ4n8&_r=1) no later than 23:59 UTC+3 07.10.2022.

6.4. The Organizer shall notify the Winners by direct message on TikTok about the terms and conditions for receipt of the Valuable Prize, as well as the information required to obtain the Valuable Prize, which the Winner must provide to the Organizer within five (5) calendar days of the Organizer's request.

7. Information on the timing and procedure for Winners for receiving prizes as part of the Promotion

7.1. The Valuable Prize shall be sent to the Winner no later than 25.10.2022, to the address that the Winner provides to the Organizer (clause 6.4 of the Rules).

7.2. If the Winner does not inform the Organizer of their address, or any other information necessary for delivery of the Valuable Prize in accordance with clause 6.4 of the Rules, the Organizer reserves the right to cancel that individual's win and reduce the total number of winners of the Promotion accordingly.

7.3. The Organizer is not responsible for any consequences of mistakes made by the Participant when providing the information necessary to receive the Valuable Prize.

7.4. All costs associated with the Winner's receipt of the Valuable Prize, including government fees, taxes, and other obligatory payments (if any), shall be borne by the Winners themselves.

8. Additional terms and conditions

8.1. Fraudulent activities in order to participate in the Promotion are not allowed.

8.2. During the Promotion, the Organizer will not take into account the results of Participants who violate clause 8.1 of these Rules.

8.3. By performing the implied actions provided for in clause 4.1 of these Rules, the Participant gives their consent to the processing by the Organizer of their personal data. The Participant can withdraw their consent by sending notification to the email address dataprotection@binomo.com.

8.4. The Organizer of the Promotion is not responsible for the following:

- 1) 1) the inability (not through the fault of the Organizer) of potential participants to familiarize themselves with the rules posted by the Organizer;
- 2) the inability of Participants to familiarize themselves with the list of Winners of the Promotion posted by the Organizer;
- 3) the non-receipt/untimely receipt by the Organizer of the information necessary to receive prizes, through the fault of the Participants themselves or through the fault of communications systems, or for other reasons beyond the control of the Organizer;
- 4) non-receipt by Winners of Valuable Prizes through not claiming them or refusing to claim them;
- 5) for any consequences of mistakes made by Participants when participating in the Promotion.

8.5. The Organizer has the right at any time to amend these Rules by posting corresponding information on the Organizer's Site. Persons interested in participating in the Promotion are obliged to independently monitor for any updates of the Promotion Rules by checking for corresponding changes on the Organizer's Site.

8.6. By participating in the Promotion, the Participant fully releases TikTok from liability for the consequences of such participation.

8.7. This Promotion is not sponsored, recommended, or managed by, or affiliated with, TikTok.

8.8. By participating in the Promotion, the Participant confirms that the Organizer can use their name on TikTok when announcing the Winners.
